RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL IN FAVOR OF HACIENDA ESPERANZA COMMUNAL AGRARIAN REFORM BENEFICIARIES ASSOCIATION (HECARBA) RELATIVE TO THE DONATION OF ONE (1) UNIT ONE-STOREY MULTI-PURPOSE PROCESSING BUILDING (FLOOR AREA: 150 SQ.M.) IN THE AMOUNT OF FOUR MILLION TWO HUNDRED ELEVEN THOUSAND EIGHT HUNDRED THIRTY SEVEN PESOS AND TEN CENTAVOS (P4,211,837.10)
