RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. ARLAN H. TRONCILLO RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS ORTHOPEDIC CONSULTANT AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL EFFECTIVE FROM THE DATE OF SIGNING OF THE AGREEMENT UNTIL DECEMBER 31, 2025

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Arlan H. Troncillo relative to the engagement of his services as Orthopedic Consultant at the Teresita L. Jalandoni Provincial Hospital effective from the date of signing of the agreement until December 31, 2025;

WHEREAS, under the said agreement, Dr. Troncillo shall render at least four (4) service days per month and weekly outpatient consults and the authority to perform surgical procedures and respond to referrals and shall receive a compensation of Thirty Thousand Pesos (P30,000.00) per month and 60% of PHIC professional fees net of tax;

**WHEREAS**, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
