RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF NEGROS CULTURAL FOUNDATION, INC.

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 23, 2025, the Department of the Interior and Local Government issued Memorandum Circular No. 2025-060, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the Negros Cultural Foundation, Inc. with office address at Old Agricultural Extension Bldg., Gatuslao St., Bacolod City, Negros Occidental through Marilyn B. Gamboa its President has signified its intention to be an accredited CSO in the Province of Negros Occidental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the Negros Cultural Foundation, Inc. has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2025-060;
