RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND SAVER PLAN MEDICAL & HEALTHCARE SERVICES RELATIVE TO THE IMPLEMENTATION OF ORDINANCE NO. 005, SERIES OF 2025 OF THE PROVINCE WHICH AUTHORIZES THE UTILIZATION OF THE MEDICAL ALLOWANCE GRANTED UNDER DBM BUDGET CIRCULAR NO. 2024-6 FOR GROUP INSURANCE OR OTHER GROUP HEALTH-RELATED BENEFITS FOR ELIGIBLE OFFICIALS AND EMPLOYEES OF THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and Saver Plan Medical & Healthcare Services relative to the implementation of Ordinance No. 005, series of 2025 of the province which authorizes the utilization of the medical allowance granted under DBM Budget Circular No. 2024-6 for group insurance or other group health-related benefits for eligible officials and employees of the Provincial Government of Negros Occidental;

WHEREAS, DBM Budget Circular No. 2024-6 dated December 12, 2024 prescribes the rules and regulations on the grant of medical allowance to civilian government personnel, pursuant to Executive Order No. 64, series of 2024, dated August 2, 2024;

WHEREAS, the said circular authorizes the grant of a medical allowance of up to P7,000.00 per annum to eligible government personnel, including employees of Local Government Units (LGUs) effective January 1, 2025 and the said allowance is intended to subsidize Health Maintenance Organization (HMO)-type benefits or other health related expenditures as specified therein;

WHEREAS, the PGNO enacted Ordinance No. 005, series of 2025 authorizing the use of the medical allowance under the said circular to fund group insurance or other health-related benefits for eligible officials and employees of the province;

WHEREAS, the MOA with Saver Plan Medical & Healthcare Services provides the contractual framework for the implementation of the medical allowance, defining the obligation of both parties and ensuring the compliance with existing insurance regulations under the Insurance Commission;

WHEREAS, the proposed Schedule of Plan Benefits offered by Saver Plan Medical & Healthcare Services is hereby attached as "Annex A" and forming an integral part of this resolution;

WHEREAS, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Governor to sign, for and in behalf of the province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and Saver Plan Medical & Healthcare Services relative to the implementation of Ordinance No. 005, series of 2025 of the province which authorizes the utilization of the medical allowance granted under DBM Budget Circular No. 2024-6 for group insurance or other group health-related benefits for eligible officials and employees of the Provincial Government of Negros Occidental.

RESOLVED FURTHER, to grant authority to the Provincial Treasurer to release the funds in accordance therewith.
