RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE 6 AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE IMPLEMENTATION OF THE DOLE GOVERNMENT INTERNSHIP PROGRAM (DOLE-GIP) IN THE PROVINCE

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Department of Labor and Employment (DOLE) Regional Office 6 and the Province of Negros Occidental relative to the implementation of the DOLE Government Internship Program (DOLE-GIP) in the province;
