## RESOLUTION NO. 0910 Series of 2025

RESOLUTION APPROVING ORDINANCE NO. 2025-178 OF THE CITY OF VICTORIAS REORGANIZING THE ORGANIZATIONAL STRUCTURE AND STAFFING OF THE CITY AGRICULTURE OFFICE (CAO), DEFINING ITS MANDATE, FUNCTIONS, AND ESTABLISHING THE APPROPRIATE PERSONNEL AND POSITIONS TO IMPROVE AGRICULTURAL SERVICES, OPERATIONS AND PROGRAMS OF THE CITY

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 2025-178 of the City of Victorias reorganizing the organizational structure and staffing of the City Agriculture Office (CAO), defining its mandate, functions, and establishing the appropriate personnel and positions to improve agricultural services, operations and programs of the city;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the City of Victorias to enact and in accordance with the Section 17 (b)(4) in relation to Section 17(b)(2)(i) of R.A. 7160, otherwise known as the Local Government Code of 1991, which mandates LGUs to provide basic agricultural support services, including extension services, on-site research, facilities for the use of farmers and fisherfolks, and other related programs to improve agricultural productivity;
