***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF
THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY
AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE HINOBA-AN
RURAL HEALTH AND BIRTHING FACILITY RELATIVE TO THE REFERRAL OF
PATIENTS OF THE SAID FACILITY TO THE ELEUTERIO T. DECENA MEMORIAL
HOSPITAL FOR LABORATORY, PHARMACEUTICAL, DENTAL, IMAGING AND
AMBULANCE SERVICES FOR THE PERIOD OF ONE YEAR EFFECTIVE UPON
SIGNING THEREOF***

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Hinoba-an Rural Health and Birthing Facility relative to the referral of patients of the said facility to the Eleuterio T. Decena Memorial Hospital for laboratory, pharmaceutical, dental, imaging and ambulance services for the period of one year effective upon signing thereof;

WHEREAS, the subject MOA is compliant with the mandate in Section 33 of the Local Government Code (RA 7160) which authorizes local government units to enter into cooperative agreements to enhance service delivery. It is likewise aligned with Republic Act No. 11223 (Universal Health Care Act), particularly in the development of province-wide health systems and the integration of primary care networks;
