## RESOLUTION NO. 0913 Series of 2025

RESOLUTION APPROVING ORDINANCE NO. 2025-180 OF THE CITY OF VICTORIAS CREATING THE BALIK PAHUWAY CADAVER REPATRIATION PROGRAM OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL

**WHEREAS**, thereby presented for appropriate action of the Board is Ordinance No. 2025-180 of the City of Victorias creating the Balik Pahuway Cadaver Repatriation Program of the City of Victorias, Negros Occidental;

WHEREAS, the enactment of the subject ordinance finds legal support from the Local Government Code of 1991 (RA 7160), specifically Section 16 of the said Code which empowers Local Government Units to undertake activities and programs that promote the welfare of their constituents;

WHEREAS, the ordinance is likewise in line with the Constitutional mandate, which provides that: "The State values the dignity of every human person ang guarantees full respect for human rights;"

WHEREAS, in the interest of social justice and public compassion, City Ordinance No. 2025-180 establishes the "Balik Pahuway Program," which institutionalizes a local mechanism that addresses the lack of accessible and structured assistance for cadaver repatriation. It ensures that the passed-on constituents of the City of Victorias are given an opportunity for a dignifies return to their hometown for burial;
