RESOLUTION APPROVING ORDINANCE NO. 25-16 OF THE CITY OF SAN CARLOS ADOPTING THE AMENDMENT OF MEMORANDUM CIRCULAR NO. 06, SERIES OF 2023, "REVISED GUIDELINES ON THE IMPLEMENTATION OF THE ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS)"

WHEREAS, thereby presented for appropriate action of the Board is Ordinance No. 25-16 of the City of San Carlos adopting the amendment of Memorandum Circular No. 06, series of 2023, "Revised Guidelines on the Implementation of the Assistance to Individuals in Crisis Situation (AICS);"

WHEREAS, the Assistance to Individuals in Crisis Situation (AICS) is a program primarily implemented by the Department of Social Welfare and Development (DSWD) to provide medical, burial, transportation, education and other forms of aid to individuals and families in crisis;

WHEREAS, Memorandum Circular No. 06, series of 2023, was issued to streamline and update the rules and procedures in extending such assistance, ensuring efficiency, transparency, and consistency in its application;

WHEREAS, the adoption of the said memorandum circular by the City of San Carlos through its City Ordinance No. 25-16 is consistent with the powers of local government units under Section 16 of the Local Government Code of 1991, which provides that every local government unit shall exercise powers necessary and incidental for effective governance, particularly in promoting the general welfare.
