RESOLUTION DECLARING ORDINANCE NO. 2025-177 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL, INSTITUTIONALIZING THE PARENT EFFECTIVENESS SERVICE (PES) PROGRAM IN THE CITY OF VICTORIAS PURSUANT TO REPUBLIC ACT NO. 11908, INTEGRATING IT UNDER THE CITY'S EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL, AND PROVIDING MECHANISMS FOR ITS IMPLEMENTATION, MONITORING AND FUNDING AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Ordinance No. 2025-177 of the City of Victorias, Negros Occidental, entitled: "AN ORDINANCE INSTITUTIONALIZING THE PARENT EFFECTIVENESS SERVICE (PES) PROGRAM IN THE CITY OF VICTORIAS PURSUANT TO REPUBLIC ACT NO. 11908, INTEGRATING IT UNDER THE CITY'S EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL, AND PROVIDING MECHANISMS FOR ITS IMPLEMENTATION, MONITORING AND FUNDING" was submitted for review by the City of Victorias to the Sangguniang Panlalawigan of Negros Occidental;
