RESOLUTION APPROVING CITY ORDINANCE NO. 2025-010 OF THE CITY OF SAGAY, NEGROS OCCIDENTAL, GRANTING A MONTHLY ALLOWANCE TO THE PRESIDENTS OF BARANGAY ASSOCIATION OF PERSONS WITH DISABILITY OF THE TWENTY FIVE (25) BARANGAYS OF THE CITY OF SAGAY, APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of Negros Occidental is City Ordinance No. 2025-010 of the City of Sagay, Negros Occidental, entitled: "AN ORDINANCE GRANTING A MONTHLY ALLOWANCE TO THE PRESIDENTS OF BARANGAY ASSOCIATION OF PERSONS WITH DISABILITY OF THE TWENTY FIVE (25) BARANGAYS OF THE CITY OF SAGAY, APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES";

WHEREAS, the ordinance finds legal basis under the policy of the State, as enshrined in Republic Act No. 7277, otherwise known as the Magna Carta for Disabled Persons, as amended by Republic Act No. 9442 and Republic Act No. 10754, which mandates government entities to promote the rehabilitation, self-development, and self-reliance of persons with disabilities and to integrate them into the mainstream of society;

WHEREAS, supporting the PWD leaders through a modest allowance ensures that they can effectively carry out their roles in assisting the City and barangays in the implementation of

PWD-related programs, thereby directly contributing to the promotion of health, safety, social justice, and the comfort and convenience of the inhabitants of Sagay City;

WHEREAS, the appropriation of funds for this purpose is likewise valid, provided that the same has been included in or is aligned with the approved budget of the City Government of Sagay, as pre-reviewed by the Provincial Legal Office;

WHEREAS, in view of the foregoing, the SP Committee on Persons with Disability, finding the subject matter to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Richard Julius L. Sabalan, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 2025-010 of the City of Sagay, Negros Occidental granting a monthly allowance to the presidents of Barangay Association of Persons with Disability of the twenty five (25) barangays of the City of Sagay, appropriating funds thereof and for other purposes.
