RESOLUTION NO. 0922 Series of 2025

RESOLUTION APPROVING CITY ORDINANCE NO. 2025-009 OF THE CITY OF SIPALAY CREATING AND ORGANIZING THE CITY GOVERNANCE TRANSITION TEAM (CGTT) AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2025-009 of the City of Sipalay creating and organizing the City Governance Transition Team (CGTT) and for other purposes;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the City of Sipalay to enact and in accordance with the Section 16 (General Welfare Clause), as well as in Section 458 of R.A. 7160, otherwise known as the Local Government Code of 1991, which vests the SP, as the legislative body of the city, with the power to enact ordinances and approve resolutions necessary for an efficient and effective city government, including measures that ensure the proper and effective delivery of basic services and facilities as proved under Section 17 thereof;

WHEREAS, in view of the foregoing, the SP Committee on Good Government recommends approval of the same;
