WHEREAS, on June 23, 2025, the Department of the Interior and Local Government issued Memorandum Circular No. 2025-060, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the BFCCCI Foundation, Inc. with office address at Chamber Bldg., 3<sup>rd</sup> Floor, Ipil Avenue, Capitol Shopping Center, Villamonte, Bacolod City, Negros Occidental through Alfredo G. Barcelona its President has signified its intention to be an accredited CSO in the Province of Negros Occidental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;
