RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE SCHOLARSHIP AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND SCHOLARSHIP GRANTEES OF THE SCHOLARSHIP FOR LOCAL LEADERS ON BARANGAY GOVERNANCE (EXECUTIVE CERTIFICATE PROGRAM ON BARANGAY LEADERSHIP AND GOVERNANCE (ECP-BLG) RELATIVE TO THE GRANT OF SCHOLARSHIP BENEFITS TO SELECTED BARANGAY OFFICE AND LEADERS UNDER THE ECP-BLG ADMINISTERED BY THE CARLOS HILADO MEMORIAL STATE UNIVERSITY (CHMSU)

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Scholarship Agreement to be entered into by and between the Province of Negros Occidental and scholarship grantees of the Scholarship for Local Leaders on Barangay Governance (Executive Certificate Program on Barangay Leadership and Governance (ECP-BLG) relative to the grant of scholarship benefits to selected barangay office and leaders under the ECP-BLG administered by the Carlos Hilado Memorial State University (CHMSU);

**WHEREAS**, the scholarship agreement outlines the rights and obligations of both parties, covering scholarship benefits, the grantee's commitment to complete the program and follow CHMSU's requirements, the duty to render service to the barangay or province, ground for termination, and its effectivity;
