RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2025 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL, COVERING THE FY 2025 SUPPLEMENTAL BUDGET NO. 1 OF THE SAID MUNICIPALITY IN THE AMOUNT OF FOUR MILLION TWO HUNDRED THOUSAND PESOS (P4,200,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 Supplemental Budget No. 1 of the Municipality of San Enrique, Negros Occidental with a total appropriation of Four Million Two Hundred Thousand Pesos (P4,200,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 1, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety effective July 16, 2025, the Appropriation Ordinance No. 1, Series of 2025 of the Municipality of San Enrique, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code of 1991, and further subject to the following conditions and reminders:

- The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular (MC) No. 1 of the Department of Budget and Management (DBM), Department of Finance (DOF) and Department of Interior and Local Government (DILG) dated November 4, 2020;
- 2. The disbursement for Donations shall be spent solely for public purposes pursuant to Section 305(b), 335 and 351 of the LGC of 1991.

RESOLVED FURTHER, that this Resolution does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FURTHERMORE, the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
