***RESOLUTION APPROVING CITY ORDINANCE NO. 25-20 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL. CREATING THE CITY INFORMATION AND COMMUNICATIONS TECHNOLOGY DEPARTMENT (CICTD), PROVIDING FUNCTIONS AND ORGANIZATIONAL STRUCTURE AND FOR OTHER PURPOSES***

***WHEREAS***, thereby presented for appropriate action of the Sangguniang Panlalawigan of Negros Occidental is City Ordinance No. 25-20 of the City of San Carlos, Negros Occidental, entitled: "AN ORDINANCE CREATING THE CITY INFORMATION AND COMMUNICATIONS TECHNOLOGY DEPARTMENT (CICTD), PROVIDING FOR ITS FUNCTIONS AND ORGANIZATIONAL STRUCTURE AND FOR OTHER PURPOSES";

***WHEREAS***, said ordinance finds legal grounding from the Local Government Code, particularly Section 443 (c)(2) of R.A. No. 7160, which allows the sangguniang panlungsod to create such other offices as may be necessary to carry out the purposes of the city government;

***WHEREAS***, said ordinance aligns with the Department of Communications and Technology Act of 2015 of R.A. No. 10844 which focuses on leveraging technology for efficient and transparent local government services, including education, health, revenue, and civic purposes;

***WHEREAS***, the City of San Carlos has not exceeded the 45% Personal Services Ceiling and still has an available allowable amount of Twenty Six Million Six Hundred Eighty Six
