RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 002, SERIES OF 2025 OF THE MUNICIPALITY OF MANAPLA APPROVING THE CREATION OF NEW PLANTILLA POSITIONS TO WIT: A) LOCAL DRRM ASSISTANT (SG 8/1) UNDER THE LDRRMO; B) ADMINISTRATIVE OFFICER II (SG11/1) UNDER THE MUNICIPAL BUDGET OFFICE; AND C) LOCAL ASSESSMENT OPERATIONS OFFICER I (SG 11/1) UNDER THE MUNICIPAL ASSESSOR'S OFFICE

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 002, series of 2025 of the Municipality of Manapla approving the creation of new plantilla positions to wit: a) Local DRRM Assistant (SG 8/1) under the LDRRMO; b) Administrative Officer II (SG11/1) under the Municipal Budget Office; and c) Local Assessment Operations Officer I (SG 11/1) under the Municipal Assessor's Office;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Manapla to enact and in accordance with the Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991 and subject to the limitation specifically provide under Section 325 of the said code;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;

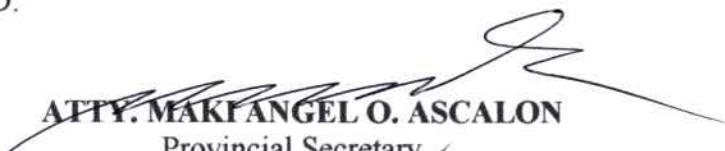
