RESOLUTION NO. 1033 Series of 2025

RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 001, SERIES OF 2025 OF THE MUNICIPALITY OF MANAPLA LOCALIZING RA 10152 ENTITLED: "AN ACT PROVIDING FOR MANDATORY BASIC IMMUNIZATION SERVICES FOR INFANTS AND CHILDREN AND PROVIDING FUNDS THEREOF"

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 001, series of 2025 of the Municipality of Manapla localizing RA 10152 entitled: "An act providing for mandatory basic immunization services for infants and children and providing funds thereof";

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Manapla to enact and in accordance with the Section 15 and Section 16 (General Welfare Clause) of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;
