

RESOLUTION APPROVING RESOLUTION NO. 2025-080 OF THE CITY OF ESCALANTE APPROVING THE CY 2026 ANNUAL INVESTMENT PLAN (AIP) OF THE CITY GOVERNMENT OF ESCALANTE IN THE TOTAL AMOUNT OF P3,468,585,829.00

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-080 of the City of Escalante approving the CY 2026 AIP of the City Government of Escalante in the total amount of P3,468,585,829.00;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Panlungsod of the City of Escalante to enact and the adoption thereof is essential as it serves as the basis for the funding of several programs, projects and activities of the city which shall; be supported and implemented through the enactment of a corresponding appropriation ordinance for the ensuing year, as indicated in the city's SP Resolution No. 2025-080;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
