RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-001-D OF THE MUNICIPALITY OF ILOG CREATING VARIOUS POSITIONS UNDER THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2025-001-D of the Municipality of Ilog creating various positions under the different offices of the Local Government Unit of the Municipality of Ilog, Negros Occidental;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Ilog to enact and in accordance with the Section 76 of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;
