RESOLUTION NO. 1053 Series of 2025

RESOLUTION APPROVING CITY ORDINANCE NO. 25-21 OF THE CITY OF SAN CARLOS, ENTITLED: "AN ORDINANCE IMPLEMENTING THE PARTIAL REORGANIZATION OF THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN OF THE CITY GOVERNMENT OF SAN CARLOS, NEGROS OCCIDENTAL, PURSUANT TO SECTION 76 OF R.A. 7160 AND R.A. 6758"

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 25-21 of the City of San Carlos, entitled: "An Ordinance implementing the Partial Reorganization of the Organizational Structure and Staffing Pattern of the City Government of San Carlos, Negros Occidental, pursuant to Section 76 of R.A. 7160 and R.A. 6758" was submitted for review by the City of San Carlos to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, the enactment of the abovementioned City Ordinance is an adoption of the national laws explicitly mentioned in the title itself. Section 76 of the Local Government Code provides that:

Section 76. Organizational Structure and Staffing Pattern. – Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

WHEREAS, it also finds legal standing from the Compensation and Position Classification Act of 1989 which provides:

Section 2. Statement of Policy. – It is hereby declared the policy of the State to provide equal pay for substantially equal work and to base differences in pay upon substantive differences in duties and responsibilities and qualification requirements of the positions...xxx

WHEREAS, the ordinance essentially operationalizes the authority of the local government to establish and implement its staffing pattern and organizational structure, provided that the same adheres to the minimum standards set by the Civil Service Commission and remains within the financial capability of the city;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource, recommends approval of the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa and duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve City Ordinance No. 25-21 of the City of San Carlos, entitled: "An Ordinance implementing the Partial Reorganization of the Organizational Structure and Staffing Pattern of the City Government of San Carlos, Negros Occidental, pursuant to Section 76 of R.A. 7160 and R.A. 6758" was submitted for review by the City of San Carlos to the Sangguniang Panlalawigan of Negros Occidental.

This resolution shall take effect immediately upon approval.
