AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED TEN MILLION PESOS (P110,000,000.00) FOR THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE PROVINCE OF NEGROS OCCIDENTAL

BE IT ENACTED by the Sangguniang Panlalawigan of Negros Occidental in a regular session duly assembled that:

SECTION 1. GENERAL FUND – The amount of ONE HUNDRED TEN MILLION PESOS (P110,000,000.00) is hereby appropriated for the 2025 General Fund Supplemental Budget No. 6 of the Province of Negros Occidental, which is summarized as follows:

SECTION 2. The maximum rate of the Performance-Based Bonus (PBB) for officials and employees of the Provincial Government of Negros Occidental shall be at 100% of each qualified individual's 50% basic monthly salary as of December 31, 2023 pursuant to Joint Memorandum Circular No. 2025-001 of the Department of Interior and Local Government and the Department of Budget and Management dated April 30, 2025.

SECTION 3. The appropriation for purchase of land covered under TCT No. T-271666 located at Brgy. 7, Poblacion, Moises Padilla, Negros Occidental per Appropriation Ordinance No. 2025-03 (2025 SB No. 3) in the amount of Twenty Five Million Pesos (P25,000,000.00) shall no longer proceed.

SECTION 4. This Appropriation Ordinance shall take effect immediately upon approval.
