RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE MUNICIPALITY OF DON SALVADOR BENEDICTO RELATIVE TO THE REFERRAL OF PATIENTS OF THE RURAL HEALTH UNIT (RHU) OF THE SAID MUNICIPALITY FOR CLINICAL LABORATORY, DIAGNOSTIC, RADIOLOGIC, PHARMACY, DENTAL, BIRTHING AND AMBULANCE SERVICES TO THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL EFFECTIVE FOR FIVE (5) YEARS UPON SIGNING THEREOF AND RENEWABLE BY MUTUAL CONSENT

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Municipality of Don Salvador Benedicto relative to the referral of patients of the Rural Health Unit (RHU) of the said municipality for clinical laboratory, diagnostic, radiologic, pharmacy, dental, birthing and ambulance services to the Teresita L.
