RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CITY OF HIMAMAYLAN RELATIVE TO THE REFERRAL OF PATIENTS OF THE PRIMARY CARE FACILITY 1 (PCF1) OF THE SAID CITY FOR PHARMACEUTICAL, LABORATORY, IMAGING, DENTAL AND AMBULANCE SERVICES TO THE GOV. VALERIANO M. GATUSLAO MEMORIAL HOSPITAL, AS WELL AS PERSONNEL AUGMENTATION FOR HEALTH INFORMATION MANAGEMENT AND ICD-10 COMPLIANCE IN SUPPORT TO THEIR OPERATIONS AND LICENSING COMPLIANCE AND WILL BE VALID FOR ONE YEAR UPON SIGNING THEREOF UNLESS EARLIER TERMINATED

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the City of Himamaylan relative to the referral of patients of the Primary Care Facility 1 (PCF1) of the said city for pharmaceutical, laboratory, imaging, dental and ambulance services to the Gov. Valeriano M. Gatuslao Memorial Hospital, as well as personnel augmentation for Health Information Management and ICD-10 Compliance in support to their operations and licensing compliance and will be valid for one year upon signing thereof unless earlier terminated;

WHEREAS, the subject agreement provides for ancillary service provision by the Gov. Valeriano M. Gatuslao Memorial Hospital in support of Himamaylan City PCF1, which lacks several DOH licensing requirements such as a licensed laboratory, pharmacy, imaging facility, dentist, and ambulance;

WHEREAS, the subject agreement is a valid exercise of inter-LGU cooperation under Section 33 of the Local Government Code, which expressly authorizes local government units to enter into cooperative arrangements to jointly deliver basic services. Furthermore, it is also aligned with the Universal Health Care Act (RA 11223), particularly in ensuring integration of primary care networks with the higher-level hospitals and delineates the roles, obligations and accountabilities of the parties, provides mechanisms for implementation and compliance, and ensures service continuity for the benefit of patients;

WHEREAS, in view of the foregoing, the SP Committee on Health, finding the same to be in order, deemed it best to approve the same;


NOW THEREFORE, on motion of Hon. Araceli T. Somosa, duly seconded by all the members present,
