RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL THROUGH THE VALLADOLID DISTRICT HOSPITAL AND THE UNIVERSITY OF NEGROS OCCIDENTAL-RECOLETOS (UNO-R) RELATIVE TO THE PRACTICAL TRAINING OF THE SAID SCHOOL'S NURSING STUDENTS AT THE VALLADOLID DISTRICT HOSPITAL FOR THE PERIOD SEPTEMBER 5, 2025 TO SEPTEMBER 5, 2027
