RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, AND PLDT, INC. RELATIVE TO THE INSTALLATION, OPERATION, AND MAINTENANCE OF TELECOMMUNICATIONS FACILITIES AT THE NEGROS FIRST CYBER CENTER (NFCC)

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Provincial Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental, and PLDT, Inc. relative to the installation, operation, and maintenance of telecommunications facilities at the Negros First Cyber Center (NFCC) located at Hernaez St., Corner Lacson Street, Bacolod City

WHEREAS, Section 465 (b)(1)vi) of the Local Government Code of 1991 of R.A. No. 7160 empowers the Provincial Governor as the Local Chief Executive (LCE) of the Province to represent the province in all its business transactions and sign pertinent documents on its behalf;

WHEREAS, the installation and maintenance of telecommunications infrastructure at NFCC by PLDT will improve connectivity and technological readiness within the facility, which
