RESOLUTION APPROVING RESOLUTION NO. 25-275 OF THE CITY OF SILAY ADOPTING AND APPROVING THE SILAY CITY DEVELOPMENT COUNCIL RESOLUTION NO. 05, SERIES OF 2025, APPROVING THE AMENDMENT TO THE 2025 AIP TO INCLUDE THE PRIORITY PPAS, ENTITLED: SRI IN THE AMOUNT OF 17,000,000.00, PEI IN THE AMOUNT OF P4,500,000.00, CNA INCENTIVE AMOUNTING TO P25,000,000.00 AND PBB AMOUNTING TO P16,000,000.00

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 25-275 of the City of Silay adopting and approving the Silay City Development Council Resolution No. 05, series of 2025, approving the amendment to the 2025 AIP to include the priority PPAs, entitled: SRI in the amount of 17,000,000.00, PEI in the amount of P4,500,000.00, CNA Incentive amounting to P25,000,000.00 and PBB amounting to P16,000,000.00;
