RESOLUTION NO. 1090 Series of 2025

RESOLUTION DECLARING CITY ORDINANCE NO. 2025-015 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL, PROVIDING ADDENDUM TO CHAPTER VII OF ORDINANCE NO. 2022-26 ALSO KNOWN AS THE REVISED MARKET CODE OF VICTORIAS CITY TO REFLECT MODERNIZATION AND INFRASTRUCTURE MOVEMENT AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 2025-015 of the City of Victorias, entitled: "AN ORDINANCE PROVIDING ADDENDUM TO CHAPTER VII OF ORDINANCE NO. 2022-26 ALSO KNOWN AS THE REVISED MARKET CODE OF VICTORIAS CITY TO REFLECT MODERNIZATION AND INFRASTRUCTURE MOVEMENT" was submitted for review by the City of Victorias to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, the subject ordinance of the City of Victorias adds a provision to Chapter VII of the Revised Market Code, which states:

"Section 63.1. MODERNIZATION AND INFRASTRUCTURE. The city government shall allocate budget or enter PPPs to improve: drainage, roofing and electrical safety, CCTV and lighting, digital payment systems and market wifi, maintain a digital vendor registry and explore online selling platforms for vendors."

WHEREAS, the aforementioned City Ordinance of the City of Victorias is consistent with the applicable national and local laws, as pre-reviewed by the Provincial Legal Office;

NOW THEREFORE, on motion of Hon. Laurence Marxlen J. de la Cruz, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to pass and approve this resolution, to wit:
