RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2025 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL, COVERING THE FY 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 IN THE AMOUNT OF FOUR MILLION SIXTY EIGHT THOUSAND SIX HUNDRED EIGHTY EIGHT PESOS AND SIXTY THREE CENTAVOS (P4,068,688.63)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2025 General Fund Supplemental Budget No. 3 of the Municipality of E.B. Magalona, Negros Occidental with a total appropriation of Four Million Sixty Eight Thousand Six Hundred Eighty Eight Pesos and Sixty Three Centavos (P4,068,688.63), enacted by the Sangguniang Bayan of the said municipality per Appropriation Ordinance No. 03, Series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual, 2023 Edition for Local Government Units and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;
