RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF HDA. SAN GERMAN-GAMBOA SWITCH INTEGRATED FARMERS ASSOCIATION IN THE PROVINCE OF NEGROS OCCIDENTAL


RESOLVED FURTHER, that this accreditation is effective only until June 30, 2028.
