RESOLUTION APPROVING FOR FIRST READING OF THE PROPOSED ORDINANCE ENTITLED: "AN ORDINANCE ESTABLISHING THE PROVINCIAL INDIGENOUS PEOPLES AFFAIRS OFFICE (PIPAO) AND THE PROVINCIAL INDIGENOUS PEOPLES CONSULTATIVE COUNCIL (PIPCC) IN THE PROVINCE OF NEGROS OCCIDENTAL, DEFINING THEIR MANDATES, STRUCTURES, AND FUNCTIONS, RECOGNIZING THE ROLE OF INDIGENOUS **PEOPLES** MANDATORY REPRESENTATIVES (IPMRs), ENCOURAGING THE CREATION OF MUNICIPAL AND CITY IP AFFAIRS OFFICES, AND INSTITUTIONALIZING PARTNERSHIP WITH THE NATIONAL COMMISSION ON INDIGENOUS PEOPLES (NICP) AND THE NATIONAL COMMISION FOR CULTURE AND THE ARTS (NCCA)"
