RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE SPECIFIC ROADS AND OTHER INFRASTRUCTURE PROJECTS CHARGEABLE AGAINST THE LUMP-SUM APPROPRIATION UNDER SB. NO. 5, SERIES OF 2025 — CONSTRUCTION/UPGRADING OF PROVINCIAL ROAD AND OTHER ROAD NETWORK AND INFRASTRUCTURES IN THE TOTAL AMOUNT OF ONE HUNDRED NINETY SEVEN MILLION EIGHT HUNDRED FORTY THREE THOUSAND SIX HUNDRED TWENTY NINE PESOS AND FIFTY FIVE CENTAVOS (P197,843,629.55)
