RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-205 OF THE MUNICIPALITY OF MOISES PADILLA, NEGROS OCCIDENTAL, AUTHORIZING HONORABLE FELIX MATHIAS SEGUNDO F. YULO III, MUNICIPAL VICE-MAYOR, THE AUGMENTATION OF THE AMOUNT OF SEVENTY FIVE THOUSAND PESOS (P75,000.00) FROM THE IN AID OF LEGISLATION AND ADVERTISING EXPENSES BUDGETS TO THE OTHER EXPENSE BUDGET, ALL UNDER THE OFFICE OF THE SANGGUNIANG BAYAN, AND FOR OTHER PURPOSES

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2025-205 of the Municipality of Moises Padilla, Negros Occidental, entitled: "AN ORDINANCE AUTHORIZING HONORABLE FELIX MATHIAS SEGUNDO F. YULO III, MUNICIPAL VICE-MAYOR, THE AUGMENTATION OF THE AMOUNT OF SEVENTY FIVE THOUSAND PESOS (P75,000.00) FROM THE IN AID OF LEGISLATION AND ADVERTISING EXPENSES BUDGETS TO THE OTHER EXPENSE BUDGET, ALL UNDER THE OFFICE OF THE SANGGUNIANG BAYAN, AND FOR OTHER PURPOSES;

WHEREAS, the above-mentioned ordinance was enacted by the Sangguniang Bayan that embodies the augmentation of the amount of Seventy Five Thousand Pesos (P75,000.00) from the In Aid of Legislation and Advertising Expenses Budgets to the Other Expense Budget, all under

the Office of the Sangguniang Bayan, shall be within the purview of Section 336 of Republic Act No. 7160 which states that:

"Use of Appropriated Funds and Savings. – Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the Sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations."

WHEREAS, Article 454 (b)(2) of the Implementing Rules and Regulations (IRR) of R.A. 7160, provides that:

"xxx. (2) Augmentation implies the existence in the budget of an item, project, activity or purpose with an appropriation which upon implementation or subsequent evaluation of needed resources is determined to be deficient."

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Laurence Marxlen J. de la Cruz, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Municipal Ordinance No. 2025-205 of the Municipality of Moises Padilla, Negros Occidental, subject to the above-cited provisions of R.A. 7160.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
