
WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-147 of the City of Talisay approving CDC Resolution No. 201, series of 2025, thereby approving the re-programming of the 20% Annual Development Fund unexpended balances in the amount of P2,906,685.53;
