RESOLUTION APPROVING RESOLUTION NO. 2025-148 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, APPROVING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 202, SERIES OF 2025, THEREBY APPROVING THE CALENDAR YEAR 2025 SUPPLEMENTAL INVESTMENT PROGRAM (SIP) IN THE AMOUNT OF EIGHT MILLION TWO HUNDRED SIXTY TWO THOUSAND ONE HUNDRED THIRTY NINE PESOS AND SEVENTEEN CENTAVOS (\$\mathbb{P}\mathbb{8}\,262,139.17)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2025-148 of the City of Talisay, Negros Occidental, entitled: "A RESOLUTION APPROVING CDC RESOLUTION NO. 202, SERIES OF 2025, THEREBY APPROVING THE CALENDAR YEAR 2025 SUPPLEMENTAL INVESTMENT PROGRAM (SIP) IN THE AMOUNT OF EIGHT MILLION TWO HUNDRED SIXTY TWO THOUSAND ONE HUNDRED THIRTY NINE PESOS AND SEVENTEEN CENTAVOS (₱8,262,139.17);
