WHEREAS, thereby presented to the Board for appropriate action of the Sangguniang Panlalawigan is Appropriation Ordinance No. 05, Series of 2025 of the City of Silay, Negros Occidental entitled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF NINE HUNDRED SIXTY FOUR THOUSAND EIGHT HUNDRED SEVENTY PESOS (P964,870.00) FOR THE SUPPLEMENTAL BUDGET NO. 04 OF THE GENERAL FUND OF THE CITY OF SILAY FOR CALENDAR YEAR 2025";

WHEREAS, the pre-review shows substantial compliance with the same law, the Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;

WHEREAS, the same is recommended for approval and declared operative in its entirety subject to the posting requirements under Section 59 of LGC 1991. However, the local government unit is encouraged to indicate the AIP Reference codes under column three (3) of Local Budget Preparation Form No. 9 (Statement of Supplemental Appropriation). The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP;
