## RESOLUTION NO. 1143 Series of 2025

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2025 OF THE MUNICIPALITY OF TOBOSO, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION FIVE HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED PESOS (P2,534,800.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 3 of the Municipality of Toboso, Negros Occidental with a total appropriation of P2,534,800.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 03, series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 03, series of 2025 of the Municipality of Toboso covering the 2025 General Fund Supplemental Budget No. 3 of the said municipality with a total appropriation of P2,534,800.00 and considered operative in its entirety effective September 3, 2025 subject to the posting requirement under Section 59 of LGC 199.

## RESOLVED FURTHER, that the municipality is reminded of the following:

- the purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14, dated December 10, 2028; Budget Circular No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the DBM; and
- that Section 54 of the LGC provides that every ordinance enacted by the Sangguniang Bayan shall be presented to the municipal mayor, as the case maybe, if the LCE approves the same, he shall affix his signature on each and every page thereof.

**RESOLVED FURTHERMORE**, that it is understood that the review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
