RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DEED OF ABSOLUTE SALE TO BE ENTERED INTO BY AND BETWEEN SPOUSES ERNESTO D. DADA AND ROSEMARIE PERUELO AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE SALE OF A PROPERTY IDENTIFIED AS LOT 9-A-13, UNDER TCT NO. CARP2019006530, SITUATED IN BARANGAY MINOYAN, MURCIA, NEGROS OCCIDENTAL, WITH A TOTAL LAND AREA OF 4,959 SQUARE METERS, WITH AN APPRAISED AMOUNT OF \$\mathbb{P}650.00 PER SQUARE METER, IN THE TOTAL AMOUNT OF \$\mathbb{P}3,223,350.00.

WHEREAS, the request from Gov. Eugenio Jose "Bong" Lacson, dated October 14, 2025, has been forwarded to the Sangguniang Panlalawigan concerning the Deed of Absolute Sale between Spouses Ernesto D. Dada and Rosemarie Peruelo and the Province of Negros Occidental;

WHEREAS, the Province of Negros Occidental intends to acquire the said property identified as Lot 9-A-13, under TCT No. CARP2019006530, situated in Barangay Minoyan, Murcia, Negros Occidental, with a total land area of 4,959 square meters, appraised at ₱650.00 per square meter, amounting to ₱3,223,350.00;

WHEREAS, the document is aligned with the R.A. 7160 otherwise of the Local Government Code especially under the General Welfare Clause, to wit:

powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.
