RESOLUTION AMENDING SANGGUNIAN PANLALAWIGAN RESOLUTION NO. 0448, SERIES OF 2025 RELATIVE TO THE CHANGE OF NAME AND LOCATION OF THE ELEUTERIO T. DECENA MEMORIAL HOSPITAL TO HINOBA-AN DISTRICT HOSPITAL LOCATED AT BARANGAY POOK, HINOBA-AN, NEGROS OCCIDENTAL AND THE UPGRADING OF ITS CLASSIFICATION FROM A 10-BED INFIRMARY TO A 25-BED LEVEL 1 HOSPITAL, IN ACCORDANCE WITH DOH STANDARDS AND APPLICABLE LAWS

WHEREAS, thereby presented to the Board for review and appropriate action is the request for the amendment of Sangguniang Panlalawigan Resolution No. 0448, series of 2025 relative to the change of name and location of Eleuterio T. Decena Memorial Hospital to Hinoba-an District Hospital located at Brgy. Pook, Hinoba-an, Negros Occidental and the upgrading of its classification from a 10-bed infirmary to a 25-bed level 1 hospital, in accordance with DOH standards and applicable laws;

WHEREAS, the Sangguniang Panlalawigan approved on its SP Resolution No. 0448, series of 2025 the change of name of the hospital from Eleuterio T. Decena Memorial Hospital to Hinoba-an District Hospital in view of its relocation and development of a new facility;

WHEREAS, the present resolution seeks to clarify and expand the scope of the said SP Resolution to also include the upgrading of the hospital from a 10-bed infirmary to a 25-bed Level 1 hospital, consistent with applicable laws, rules and standards of the department of Health (DOH);

WHEREAS, the amendment is in line with Section 17(b)(3)(iv) and Section 465(b)(1)(vi) of the Local Government Code of 1991, wherein provincial governments are mandated to establish, maintain, and upgrade hospitals and other tertiary health services, and the Provincial Governor is empowered to represent the province in such matters.

WHEREAS, the request is consistent with the ongoing development and expansion of the new hospital site and aims to ensure full regulatory compliance with DOH facility standards and PhilHealth accreditation requirements;

WHEREAS, the upgrading and relocation of the hospital is in line with the Universal Health Care Act, which promotes equitable access to health services and infrastructure, especially in the underserved areas such as the southern part of the province;

WHEREAS, the proposed amendment does not alter the intent of SP Resolution No. 0448, series of 2025, but rather enhances its coverage;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;

NOW, THEREFORE, on motion of Hon. Araceli T. Somosa, and unanimously seconded by all members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve the amendment of Sangguniang Panlalawigan Resolution No. 0448, series of 2025 relative to the change of name and location of Eleuterio T. Decena Memorial Hospital to Hinoba-an District Hospital located at Brgy. Pook, Hinoba-an, Negros Occidental and the upgrading of its classification from a 10-bed infirmary to a 25-bed level 1 hospital, in accordance with DOH standards and applicable laws.


