TO CONSTRUCT, OPERATE, AND MAINTAIN A 113.9 MW PEAK SOLAR POWER PROJECT IN BARANGAY BLUMENTRITT, MUNICIPALITY OF MURCIA, NEGROS OCCIDENTAL

WHEREAS, the Murcia Solar Energy Project Incorporated is a hundred percent Philippine-owned company that has shown sincere interest in the construction, operation, and maintenance of a 113.9 MW Peak Solar Power Project in the aforementioned locality;

WHEREAS, the site location for the construction of the aforementioned Solar Project is owned by the Montelibano Family in Barangay Blumentritt, Municipality of Murcia, Negros Occidental:

WHEREAS, in support of the Republic Act 9513 or Renewable Energy Act of 2008, wherein the power mix of 35% may be achieved by the year 2030, renewable energy shall constitute 30%, and non-renewable energy shall constitute 70%;

WHEREAS, the tentative target of operation will be sometime in 2027, which will add benefits and income to the Provincial Government as much as 1.5 percent of the gross income, to be distributed at 60% to the National Government and 40% to the Province of Negros Occidental, the Municipality, and the respective Barangay;

WHEREAS, this Resolution is in support of the Provincial Government's thrust to make Negros Occidental a Green Province in the entire Republic of the Philippines;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
