
**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 06, SERIES OF  
2025, OF THE CITY OF SILAY, NEGROS OCCIDENTAL APPROVING THE 2025  
GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID CITY IN THE  
AMOUNT OF SIXTEEN MILLION EIGHT HUNDRED THOUSAND SIX HUNDRED  
FORTY PESOS (P16,800,640.00)**

**WHEREAS**, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 06, series of 2025 of the City of Silay, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 5 of the said city in the total amount of Sixteen Million Eight Hundred Thousand Six Hundred Forty Pesos (P16,800,640.00) that was submitted to the Sangguniang Panlalawigan for review on October 8, 2025;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, CY 2016 Updated Budget Operations Manual for Local Government Units, implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 06, series of 2025 of the City of Silay, Negros Occidental approving the 2025 General Fund Supplemental Budget No. 5 of the said city in the total amount of Sixteen Million Eight Hundred Thousand Six Hundred Forty Pesos (P16,800,640.00), subject to the posting requirement under Sec. 59 of the LGC, and subject further to the condition that the utilization of the 20% Development Fund shall be in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020 and consistent with the approved Annual Investment Plan (AIP).

**RESOLVED FURTHER**, that the local government unit is encouraged to indicate the AIP reference codes under column 3 of Local Budget Preparation Form No. 9 (Statement of Supplemental Appropriation). The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP.

**RESOLVED FINALLY**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

**ADOPTED UNANIMOUSLY.**

This resolution shall take effect immediately upon approval.
