RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 1., SERIES OF 2025 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, COVERING THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 OF THE SAID CITY IN THE AMOUNT OF EIGHT MILLION THREE HUNDRED FIFTY THOUSAND SIX HUNDRED SEVENTY THREE PESOS AND SIXTY SEVEN CENTAVOS (P8,350,673.67)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2025 General Fund Supplemental Budget No. 1 of the City of Talisay, Negros Occidental with a total appropriation of P8,350,673.67, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 1, series of 2025;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;
