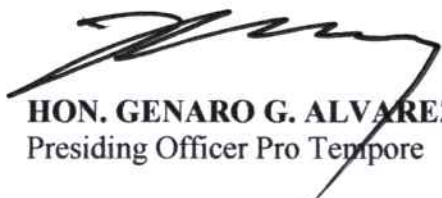
RESOLVED FURTHER, that this accreditation is effective only until June 30, 2028;

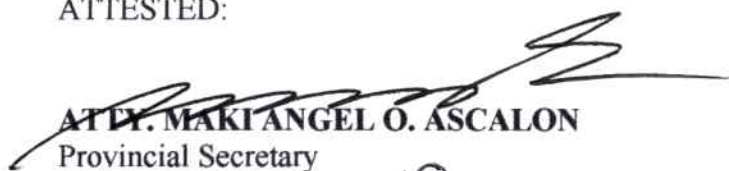
