RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF PUNTA TORIL SMALL FISHER FOLKS ASSOCIATION (PTSFFA) IN THE PROVINCE OF NEGROS OCCIDENTAL

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on June 23, 2025, the Department of the Interior and Local Government issued Memorandum Circular No. 2025-060, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, Punta Toril Small Fisher Folks Association (PTSFFA) with office address at Punta Toril, Brgy. Bocana, Ilog, Negros Occidental, through its President, Mr. Roy L. Padilla, has signified its intention to be an accredited CSO in the Province of Negros Occidental to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, Punta Toril Small Fisher Folks Association (PTSFFA) has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC No. 2025-060;
