RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE DEPARTMENT OF HEALTH - WESTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE IMPLEMENTATION OF THE HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP) IN THE TOTAL AMOUNT OF SIXTY FIVE MILLION FIVE HUNDRED THOUSAND PESOS (P65,500,000.00) CHARGEABLE AGAINST THE GENERAL APPROPRIATIONS ACT (GAA) FOR FISCAL YEAR 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Memoranda of Agreement to be entered into by and between the Department of Health - Western Visayas Center for Health Development and the Province of Negros Occidental relative to the implementation of the Health Facilities Enhancement Program (HFEP) in the total amount of Sixty Five Million Five Hundred Thousand Pesos (P65,500,000.00) chargeable against the General Appropriations Act (GAA) for Fiscal Year 2025;

WHEREAS, under the said agreement, the Department of Health thru its Health Facilities Enhancement Program shall transfer in full the allocated Sixty Five Million Five Hundred Thousand Pesos (P65,500,000.00) to the Province of Negros Occidental for the procurement of various medical equipment of health facilities, to wit:
