RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-010 OF THE MUNICIPALITY OF ILOG, DECLARING THE KISI-KISI FESTIVAL AS THE OFFICIAL FESTIVAL OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL AND PROVIDING FOR ITS ANNUAL CELEBRATION EVERY MARCH 25

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of Negros Occidental is Municipal Ordinance No. 2025-010 of the Municipality of Ilog, Negros Occidental, entitled: "AN ORDINANCE DECLARING THE KISI-KISI FESTIVAL AS THE OFFICIAL FESTIVAL OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL AND PROVIDING FOR ITS ANNUAL CELEBRATION EVERY MARCH 25;

WHEREAS, said ordinance have complied with the requirements prescribed under the Local Government Code of 1991 (Republic Act No. 7160);

WHEREAS, the legal basis for the municipality's authority to enact this ordinance is Section 16 of Republic Act No. 7160, which states:

SECTION 16. GENERAL WELFARE –Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential for the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance

the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among the residents, maintain peace and order, and preserve the comfort and conveniences of their inhabitants."

WHEREAS, the declaration and institutionalization of a local festival falls within the municipality's power to promote culture, heritage, tourism, and economic development for the benefit of its residents;

WHEREAS, the Committee on History, Arts and Culture, finding the subject matter to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Arthur Christopher D. Marañon, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Municipal Ordinance No. 2025-010 of the Municipality of Ilog, declaring the Kisi-Kisi Festival as the official festival of the Municipality of Ilog, Negros Occidental and providing for its annual celebration every march 25.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
