RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE MUNICIPALITY OF PULUPANDAN RELATIVE TO THE REFERRAL OF PATIENTS OF THE PULUPANDAN RURAL HEALTH UNIT (RHU) FOR AMBULANCE AND DIAGNOSTIC SERVICES TO THE VALLADOLID DISTRICT HOSPITAL

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Municipality of Pulupandan relative to the referral of patients of the Pulupandan Rural Health Unit (RHU) for ambulance and diagnostic services to the Valladolid District Hospital;

WHEREAS, the said agreement shall take effect immediately upon signing thereof and remains effective unless terminated by either party under agreed terms;

WHEREAS, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
