***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF
THE PROVINCE THE DEED OF DONATION EXECUTED BY THE PROVINCE OF
NEGROS OCCIDENTAL IN FAVOR OF THE PROVINCIAL GOVERNMENT OF
QUIRINO RELATIVE TO THE DONATION OF FIVE HUNDRED THOUSAND PESOS
(P500,000.00) TO PROVIDE ASSISTANCE FOR INTERNALLY DISPLACED PERSONS
(IDPs) AND INITIAL RECOVERY EFFORTS FOLLOWING THE DESTRUCTION
CAUSED BY TROPICAL CYCLONES NIKO, OFEL AND PEPITO***

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign the Deed of Donation executed by the Province of Negros Occidental in favor of the Provincial Government of Quirino relative to the donation of Five Hundred Thousand Pesos (P500,000.00) to provide assistance for Internally Displaced Persons (IDPs) and initial recovery efforts following the destruction caused by tropical cyclones Niko, Ofel and Pepito;

WHEREAS, the subject donation by the Provincial Government of Negros Occidental is a valid exercise of inter-LGU cooperation as contemplated under the Local Government Code of 1991;

WHEREAS, the act of Negros Occidental donating to Quirino is a concrete manifestation of solidarity and mutual assistance among provinces, especially in times of calamity, which directly advances the State policy of promoting local autonomy and empowering LGUs to become effective partners in national development under Section 2 of RA 7160;

WHEREAS, the donation's purpose to provide assistance for Internally Displaced Persons (IDPs) falls within the general welfare clause under Section 16 of RA 7160, which obliges LGUs, which obliges LGUs to ensure health, safety, and the comfort of their inhabitants;

WHEREAS, in view of the foregoing, the Committee on Disaster Preparedness, finding the documents to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Genaro G. Alvarez IV, and duly seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves to authorize the governor to sign for and in behalf of the Province of Negros Occidental the Deed of Donation executed by the Province of Negros Occidental in favor of the Provincial Government of Quirino relative to the donation of Five Hundred Thousand Pesos (P500,000.00) to provide assistance for Internally Displaced Persons (IDPs) and initial recovery efforts following the destruction caused by tropical cyclones Niko, Ofel and Pepito.

This resolution shall take effect immediately upon approval.


