## **RESOLUTION NO. 0979** Series of 2025

RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONTRACT FOR ELECTRIC SERVICE (CFES) TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE NEGROS ELECTRIC POWER CORP. (NEPC) RELATIVE TO THE INSTALLATION OF THREE PHASE LINE EXTENSION, TRANSFORMER AND OTHER ELECTRICAL WORKS, ELECTRIC SERVICE CONTRACT AND APPLICATION FOR SERVICE CONNECTION AND OTHER DOCUMENTS WITH REGARDS TO POWER ENERGIZATION

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Contract for Electric Service (CFES) to be entered into by and between the Province of Negros Occidental and the Negros Electric Power Corp. (NEPC) relative to the installation of Three Phase Line Extension, Transformer and other electrical works, Electric Service Contract and Application for Service Connection and other documents with regards to power energization;

WHEREAS, the Committee on Government Assets, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Mayvelyn L. Madrid, unanimously seconded by all the members present,
