AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHTY FIVE MILLION PESOS (P85,000,000.00) FOR THE 2025 GENERAL FUND SUPPLEMENTAL BUDGET NO. 8 OF THE PROVINCE OF NEGROS OCCIDENTAL

BE IT ENACTED by the Sangguniang Panlalawigan of Negros Occidental in a regular session duly assembled that:

SECTION 1. The amount of Eighty Five Million Pesos (P85,000,000.00) is hereby appropriated for the 2025 General Fund Supplemental Budget No. 8 of the Province of Negros Occidental, which is summarized as follows:

SECTION 2. The grant of Service Recognition Incentive (SRI) shall be at Twenty Thousand Pesos (P20,000.00) each qualified employee and official subject to the condition set forth under Section 2 of Administrative Order No. 40 of the Office of the President.

SECTION 3. The grant of Gratuity Pay shall be at Seven Thousand Pesos (P7,000.00) each Job Order (JO) and Contract of Service (CoS) employee subject to the condition set forth under Section 1 of Administrative Order No. 39 of the Office of the President.

SECTION 4. Pursuant to Section 336 of RA 7160 otherwise known as the Local Government Code of 1991, the Provincial Governor or the Presiding Officer of the Sangguniang Panlalawigan, by virtue of this ordinance, is hereby authorized to augment any item in the approved supplemental budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

SECTION 5. This Appropriation Ordinance shall take effect immediately upon approval.
